WHEREAS the Guardian(s) have read the Application to Play the Paintball Game, Waiver of Liability and Assumption of Risk form hereinafter referred
to as the Application to Play; and have been invited by Pinnacle Woods Paintball LLC to inspect the Game site and the conduct of the Game; and the
Guardian(s) recognize and understand that playing involves running certain risks as expressed in the Application to Play; and

ARTICLE I: Permission to Play the Game

WHEREAS the Guardian(s) despite these and other risks, and fully understanding and conveying these risks to the Player, do hereby grant the Player
permission to play the Game conditioned upon the Player abiding by the rules as set forth by Pinnacle Woods Paintball LLC. This permission to play
the Game granted in this Article I shall be effective until the Player reaches 18 years of age, unless earlier rescinded, from the date above first written.
Article I, "Permission to Play the Game" may be resendable by Pinnacle Woods Paintball LLC. Now, therefore, the Guardian(s), in consideration of
Pinnacle Woods Paintball permitting the Player to play the Game, the receipt of which is hereby acknowledged, do hereby covenant and agree on
behalf of the Player and themselves, their heirs, executors, administrators, successors and assigns as follows:

ARTICLE II: Hold Harmless Agreement

The Guardian(s) on behalf of the Player hereby assume entire responsibility and liability for any and all injury of damage of any kind or nature whatever
(including death resulting therefrom) to all persons, including the Player or otherwise and to all property, or loss of use thereof, caused by, resulting
from, arising out of, or occurring in connection with the Player in preparation, instruction, viewing or playing the Game, whether or not conducted by
the sponsor, and if any person including the Player shall make a claim for any such damage or injury (including death resulting therefrom), whether
such claim be based upon Pinnacle Woods Paintball LLC or its agents, servants, or employees' alleged active or passive negligence to participation in
the claimed wrong; or upon any alleged breach of any statutory duty or obligation on the part of Pinnacle Woods Paintball LLC or its agents, servants,
or employees, the Guardian(s) agree(s) to indemnify and save harmless Pinnacle Woods Paintball, its agents, servants and employees and other game
players from and against any and all loss, expense, damage or injury that the Player, Pinnacle Woods Paintball, its agents, servants, or employees, or
other game players may sustain as the result of any such claim and the Guardian(s) agree(s) to assume on behalf of the Player, Pinnacle Woods Paintball
LLC, his insurers or his agents, or employees, the defense of any action at law or equity which may be brought against Pinnacle Woods Paintball, its
insurers, or his agents, servants, or employees upon such claim and to pay all costs and expenses of whatever nature resulting therefrom and connection

any judgment that may be entered against Pinnacle Woods Paintball, his insurer, and/or his agents, servants or employees in any such action. The parent
of legal guardian hereby gives permission for Pinnacle Woods Paintball LLC to authorize emergency medical treatment as may be deemed necessary
